The initial renewal from Delta Dental indicated the need for a 9.5% increase. After negotiations we were able to have the overall increase reduced to 5.5%. The PEBA dental plan hasn't had an increase in over 9 years. We also received an email from the Ashtabula Chamber of Commerce that we have been approved for membership. We received an email from Julie Mock who is the General Manager for the Fairfield Inn in Austinburg. Julie was wondering what the bed tax was used for in the Township. We received the new paperwork for 2024 Election and Faithful Performance Coverage from OTARMA in regards to John and Kanda.

Zoning Administrator Rob Lapuh attended the Ashtabula County Township meeting. The speaker spoke on trying to get the County zoning and Township zoning to work together.
