The meeting of Austinburg Twp., held Dec. 17, 2007 was called to order at 7:00pm by Chair Jerry Burke for the purpose of opening truck bids on the 1989 International truck Austinburg is selling. Trustees Spade and Frank were present.

Before bids were opened, Jerry reported that Randy, from Trend, had called him and requested that the bid he sent on the truck be pulled from those submitted. The bid from Trend was not considered due to this request.

The following bids were submitted; Rogers Auto Sales, \$2,040.00. B. Marrison, \$950.00. Signature Motors, \$2,689.99. D.L. Drelinski, \$1,252.00. Scott Harrington, \$1,576.00. Robert Arendash, \$1,876.00. P.V. Schools, \$3,255.00. Austinburg Rehab, \$2,000.00.

Res. 833-07 Janie moved to accept the bid from P.V. Schools in the amount of \$3,255.00. Jerry stated he had hoped to receive more for the truck. Lynn asked what Bill Golden had said he thought the truck was worth. Jerry said Mr. Golden indicated an amount in the low teens. Discussion on the bids was held. Jerry seconded the motion to accept the bid. The roll call vote; Frank, aye. Spade, aye. Burke, aye.

Res. 834-07 Lynn moved to adjourn the bid opening meeting. Jerry seconded. Meeting adjourned.

Bills totaled \$15,459.97. Receipts totaled \$797.34.

In correspondence we received the new maintenance agreement terms from Ziegler Heating. Discussion was held on the condition of the furnaces, and the maintenance. We have a replacement furnace to put in the old township garage behind the town hall.

Time Warner Cable sent a notice they are applying with the FCC to establish that they are subject to effective competition. When more information is received from their law firm, this information will be forwarded to the County Prosecutor.

Delta Dental sent their notice of contract renewal.

Res. 837-07 Jerry moved to sign up for the basic maintenance plan from Ziegler Heating on the furnaces in the fire hall and town hall, at a fee of \$85.00 each. Janie seconded. The roll; Frank, aye. Burke, aye. Spade, aye.

Zoning Administrator John Beninato gave the zoning report. The clean up of 3785 Woodside Dr. has been started.

Lynn reported on the zoning boards and stated she has spoken to the board members. Res. 838-07 Lynn moved the following zoning board appointments be made. On the ZBA, Pete Pasqualone will move to second alternate, Tod Mogren will take a place on the ZBA. On the Zoning Commission, Carl Chiarenza will move to second alternate. A complete list of board members and terms is on file with the township. Jerry seconded. The roll; Burke, aye. Spade, aye. Frank, aye.

Janie reported the NAD meeting will be Jan. 2, 2008 at 6:00pm. NAD will set up training on the defibrillators with Austinburg, Trumbull, Geneva Twp., Geneva, and Harpersfield. It will be a four hour course, and include CPR.

Janie checked on the insurance issues brought up by Nelson Hejduk, regarding the use of the defibrillators. She reported that the Good Samaritan Law will protect those administering help with the use of the defibrillators.

Janie said that she will ask Cindy Hejduk, Town Hall Custodian, and Fire Dept. Dependency Board to be in attendance for the Dec. 27 year end meeting.

Jerry reported he and Pete still need to go and look at some plows, they have not had a chance yet.
