The Forman Road Phase 2 OPWC Project was presented to the Board for paving of Forman Road. Res. 461-17 John moved to pass authorizing legislation submitting the Township's application to the County Engineer's Office for the OPWC Forman Road Phase 2 Project at a cost of \$250,000. Christine Harrison asked the Fiscal Officer about electricity for her home to change from CEI to NOPEC. Byron will contact NOPEC and share information with Christine.

The Fiscal Officer presented updated policy coverage from OTARMA increasing amounts and using replacement costs as the standard. Joann Arndt from Watkins answered the Board's questions regarding replacement costs for building insurance. Byron asked about the valuation of the buildings and possible updates on amounts on fire trucks. The fire trucks will become replacement costs with increased values.
