The regular meeting of the Austinburg Township Board of Trustees opened at 7:30 pm. Residents in attendance included Joe Hejduk Jr., Mike Kovacic, Lorna Masek, Bill Wilms and John Beninato.

. Res. 110-20 John moved to accept the minutes as written, Jerry seconded. The roll; Burke, aye. Dutton, aye. Kusar, aye.

Res. 111-20 Jerry moved to pay the bills, John seconded. The roll; Burke, aye. Dutton, aye. Kusar, aye.

Bills paid were \$26,412.48 and Receipts were \$6,924.68.

We received a notice in the mail that all Township liquor permits will expire Dec. 1, 2020. We received an email from Chris Stasny inquiring if a permit needs to be filed to hold a running event that uses roads in Austinburg Twp.? The event in question would be on October 18th and start at 9AM. The Zoning Commission will be holding a special meeting Wed. Sept. 30 at 5:15 pm at the Townhall. This meeting is regards to a map zoning change with the Ashtabula Growth Partnership. We received a notice that we need to decide on renewing our insurance policy with OTARMA which covers our Township property and equipment. The Ashtabula Health Dept. sent an email reporting as of 9/15/20 that there have been 647 confirmed cases and 47 deaths in Ashtabula County from the COVID 19 virus.

Res.112-20 John moved to authorizing the Inter-Fund Transfer of \$3,000 in fund 2021 to cover the cost of OPERS fees for the roadmen, Jerry seconded. The roll; Burke, aye. Dutton, aye. Kusar, aye.

Zoning Administrator John Beninato turned in his report. John B. reported on the new construction on Sidley Court. It will be about a 52,000 sq. ft. building for Volvo and Mac sales.

Chief Bill Wilms reported that the SCBA's will be coming due for testing.
