In terms of correspondence, we received the official agreement for the TIF from the County Commissioners. We received a quote from Ryan Heating and Cooling for a service contract. We received an email from NOPEC that the 2023 Community Event Grant is open again for applications. We received an email from the County Commissioners about High-Speed Internet.

Fire Chief Bill Wilms reported that everything is good with the fire department. Bill reported he put in for a grant from OTRMA. Bill reported he has notified everyone about the Indemnity Board meeting Wednesday Dec. 28.
