In terms of correspondence, we received a letter from the Andover Bank providing the the ACH Rules and Procedures which must be sent out annually. We received information from RLP Parsons Equipment. We received an email from the Ashtabula County Auditor's Office in regards to a list of new addresses issued in the townships for the Township Zoning department. We received an email from ODOT informing us that the Ohio Department of Transportation proposes to resurface SR 307 from SR 45 to SR 46 in Geneva and Saybrook townships & US 20 from the easterly Geneva Corp line to just east of Ninevah Rd within the village limits and in Austinburg & Jefferson townships. This is scheduled for spring of 2026. We received an email from the EMA office wanting to know if there is any place that needs to be cleaned up before we get severe weather.

The Fiscal Officer reported that we will be getting a credit from the Ohio Department of Job and Family Services for \$206.52 because of a reporting error. The Fiscal Officer reminded the Township Trustees she will not be at the next meeting. Sarah Frank the Zoning secretary will be covering for her.

Zoning Administrator Rob Lapuh reported he issued a permit for a new resident. A letter will be sent to the Ashtabula County Prosecutor in regards to 2679 Millcreek that needs to be cleaned up.

Fire Department Fire Chief Bill Wilms reported about a practice drill with Austinburg Elementary scheduled for Tuesday May 20<sup>th</sup>.

Ashtabula County Auditor Scott Yamamoto was in attendance for this meeting. He has been going around visiting all the different Townships and Villages in the County. Trustee John Kusar asked about the different things going through the State that could affect the Townships, for example, getting rid of property tax and the doing away with replacement levies.

Road Department Supervisor Mike Petro reviewed the work to be done at the park. Mike reported he is looking to start chip n seal as soon as possible.
