Pete reported that Koski was going to start paving on Forman Road on Wednesday, August 20th. Pete said we need to take a better look at the Water Street project. Pete said the lights were almost all completed in the Township Park. Byron said he attended the NAD meeting. Byron will contact the Ashtabula County Engineers office to notify them on the paving on Forman Road. Byron reported that the fire hydrants and parts will be \$15,000 for 3 hydrants for the Pelton Road water line project. John had nothing to report other than we will be going into executive session.

Resident Elaine Shafer asked if the high weeds could be cut back by the Mechanicsville Bridge before the Covered Bridge festival. John explained that it is the County's responsibility but they will contact them. Ted Seifert asked where the Trustees were at with getting drawings for a new fire station. John reported at this time there are no plans because of the push to eliminate property tax. The Township isn't comfortable spending money on plans until we know what is going on with this property tax proposal.
