ODOT has approved funding to help fixing the safety issues. Construction is scheduled to occur in 2027. We received an email from the Ohio Dept of Natural Resources Office of Coastal Management that they will be having a webinar on Tuesday September 10 at 1:00 pm to discuss 2025 Coastal Management Assistance Grants. We received an email from ODOT starting in the summer of 2026 there will be a chip and seal project from SR 307 starting east of SR 534 and ending at SR 45. We received a message from John Swanson on Dadeyville Road that he would like to see some signs posted like "Children at Play" or "Children with Special Needs." We received the Harpersfield newsletter.

The Fiscal Officer reported she spoke with Nelson Hejduk in regards to some items that need to be fixed in the Townhall. The Fiscal Officer reported that she talked with Melanie Joslin about the health insurance that went into effect Sept. 1, 2025. There was a 6.89% increase this year and according to her that isn't bad. There will be a slight increase in deductibles with the policy. Everything else is pretty much the same as the previous policy. The Fiscal Officer reported we had received our onsite Inspections and valuations from OTARMA in regards to our Township building. The Fiscal Officer reported on the Certification of Estimated Resources sent back from the Budget Commission for January 1, 2026. The Fire Dept is having to go with the I am Responding App. It will cost about \$900 a year. Mike Petro reached out today saying that he needs to purchase more stone for the berming of Forman Road at a rough cost of about \$20,000.
