The Fiscal Officer reported that one CD at Andover Bank has rolled over again for another 5 months at 4% and the other CD at Andover Bank will roll over in two weeks for months at 4%. The Fiscal Officer reported that she and Trustee Pete Haase met with Hudson Communications. They went over their services and prices for helping with Cyber Security. The Fiscal Officer reported we need to finish the OPWC grant for project number CG45AB/CG46AB so we can request reimbursement back to us.
